## Volunteer Agreement and Release of Liability

1. **I agree** to be a volunteer for Feral Paws Rescue Group (FPRG). I further agree to provide 48 hour notice to the volunteer coordinator in the event that I can no longer service as a volunteer.
2. **I understand** that the FPRG logo is the sole property of Feral Paws Rescue Group, and any use of such name, or images, whether in written or promotional form, must be approved by the Officers, Directors or designees of Feral Paws Rescue Group. I therefore agree not to engage in any activity using the FPRG logo or trade-name without prior approval.
3. **I understand and agree** that the Feral Paws Rescue Group website, internal files and records, including names and addresses of clients, volunteers, donors, applicants, membership lists, special event participants, and similar data are the sole property of Feral Paws Rescue Group, and that unauthorized disclosure of such information, its appropriation, changes or alternations to it may constitute a criminal offense.
4. **I understand and agree** that the behavior of animals is unpredictable and that some animals are capable of inflicting serious personal injury or death, as well as significant property damage. I acknowledge that while Feral Paws Rescue Group will take every reasonable precaution to minimize the potential of a danger posed by the animals under its care, it is never possible to guarantee the temperament and/or behavior of any animal at all times and under all circumstances. I therefore agree that if I choose to volunteer for Feral Paws Rescue Group, I will do so at my own risk.
5. **I understand and agree** that if I fail to comply with the terms of this agreement or am otherwise unable to meet the FPRG Volunteer Program requirements, I will be terminated from the Program. I further understand that I may at any time, with or without cause, be removed from my position as volunteer at the sole discretion of Feral Paws Rescue Group.
6. **I hereby agree and release, indemnify and hold harmless** Feral Paws Rescue Group, its Officers, Directors, and Agents from any and all claims, damages and liability arising from or related to my activities as a FPRG volunteer; I further agree to release, hold harmless, and indemnify Feral Paws Rescue Group, its Officers, Directors, and Agents from any and all claims, damages, and liability arising from my riding as a passenger in any motor vehicle owned or leased by Feral Paws Rescue Group, its Officers, Directors, and Agents and operated by any of them.
7. **I understand and agree** if I stop volunteering for FPRG I will promptly return all supplies, equipment, records, monies, and other items in good, clean condition.
8. **I understand and agree** if I will be sheltering or providing foster care or boarding any of Feral Paws Rescue Group animals in my home or business, I consent to FPRG visiting my home or business from time to time to observe the animals and their living conditions.
9. **I understand and agree** Feral Paws Rescue Group may refuse volunteer applications for any reason.

**I represent that I am over eighteen (18) years of age and acknowledge that I have read this agreement carefully and I fully understand its contents and implications. I am aware that this is a waiver and release of liability and indemnity agreement, and that it is binding and enforceable by law.**
